Dear Peeter Munak

My name is Mr, Klaus M. Ludwig of **Klaus & Partner Rechtsanwälte**, Berlin Germany. Actually, I got your contact information through international public records while searching for a last name similar to my late client's a business magnate by name **Derek Munak**, who lived in Germany for over a decade prior to his death, he died along with his nuclear family in the cyclone nargis which occurred in May 2, 2008 during their short holidays visit to Myanmar Burma.
